### 4 FIRST AID

**After Skin Contact:**

If on skin(on hair): Take off immediately all contaminated clothing. Rinse with water/safety shower. Call doctor if irritation persists.

**After Ingestion:**

If swallowed: Rinse mouth. Do NOT induce vomiting.

**Most Important Symptoms/Effects****Eye:**

Severe eye and or skin irritation or burns.

**Skin:**

This product can cause mild, transient skin irritation. The severity of irritation will depend on the amount of material that is applied to the skin and the speed and thoroughness that it is removed. Symptoms include redness, itching, and burning of the skin. Repeated or prolonged skin contact can produce moderate irritation(dermatitis).

Persons performing clean up work should wear adequate personal protective equipment and clothing. Spills and releases should be reported, if required, to the appropriate local, state and federal regulatory agencies.

Absorb the chemical onto sand, vermiculite, or any other non-combustible absorbent, and collect into containers for later disposal.
